NO THANK YOU ITEMS

There are some items we know we cannot sell.

To those items, we say "no thank you"--but please check with your local donation or recycle centers to see if there is a need for these items!

X items with holes, rips, after market cuts, tears, etc.

X excessively dirty or stained clothing, shoes, and other items

X out of style clothing (all clothing should be from the last 3-5 years

X items that show excessive wear (thin, pilling, elastic stretched, etc)

X camp/free shirts (VBS, church, etc.)

X adult clothing (newborn - teen only) See page 6 for acceptable brands

BOOKS: Soft, board picture, chapter educational, tween








DVDs: Rated G, PG, PG-13 only



WHAT TO SELL LARGE ITEMS

These items are a "YES!" at any of our sales (and they usually sell well)! Safety First: All items must meet safety standards. Please check for recalls and be sure all safety straps are included.





DO NOT ACCEPT

Due to safety concerns/risks, the following items are not accepted at any JBF Sales.



Adult Clothing (Unless Maternity!)

As a children's and maternity sale, we only accept adult clothing if it is specifically designed for pregnant moms. All other clothing must be for children or teens. Please refer to the following brands as a guideline for both Maternity & Teen:

Teen: Abercrombie, Hollister, Nike, Under Armour, Pink, Miss Me, Lululemon and other mall brands that teens wear. No women's/men's brands or styles.

Maternity: (Must be maternity brands). Ann Taylor, Liz Lange, Motherhood Maternity, Mimi, Old Navy/Gap, Pea in the Pod and boutique brands. No ladies brands or styles.



Boppy Lounger & Similar Items

Infants can suffocate if they roll, move, or are placed on the lounger in a position that obstructs breathing, or roll off the lounger onto an external surface, such as an adult pillow or soft bedding that obstructs breathing.

Consumers should immediately stop using the recalled loungers and contact The Boppy Company for a refund.

4moms MomaRoo & RockaRoo

On older models (as pictured), when the swing or rocker is not in use, their restraint straps can dangle below the seat and non-occupant crawling infants can become entangled in the straps, posing a strangulation hazard.

Go to 4momsrecall.expertinquiry.com to register for a FREE strap fastener. Once installed, it is safe to use and to sell at JBF.



DO NOT ACCEPT

Due to safety concerns/risks, the following items are not accepted at any JBF Sales.



Homemade Masks, Clothing, or Other Items

Due to safety risks and concerns, only factory-created masks or face coverings can be sold at JBF sales. And since homemade items are not held to the same safety standards as manufacutrued items, we are unable to accept them at our sales.



Infant Sleep Products

JBF accepts cribs, bassinets, cradles, bedside sleepers, and play yards that meet current Safety Standards set by the Consumer Product Safety Commission and JBF quality/condition standards.

For all other items marketed or intended to provide a sleeping accommodation for an infant up to 5 months of age, the product must have a stand, meet stability requirements, and have a side height of at least 7.5 inches.

All other infant sleep products are not accepted for resale at JBF.



Cribs made before June 28, 2011

All Cribs made before June 28, 2011 are no longer considered safe for infants—that includes all dropside cribs as they pose significant risks to infants. They cannot be sold or donated.

For cribs manufactured on or after June 28, 2011, a completed **Crib Waiver** is Required.



Crib Bumpers & Rail Teethers

All types of Crib Bumpers and rail protectors/teethers are no longer considered safe for cribs. These will not be accepted or sold at Just Between Friends Sales.
